## A. Non-binding Demand indications

This analysis includes non-binding demand indications for technical capacities increase over their existing level received within 8 weeks after the 6 April 2017 – entry into force of REGULATION EC 459/2017.

The involved TSO's Magyar Gáz Tranzit and Eustream. have not received any non-binding demand indications / requests for firm technical capacities increase over the existing level at the interconnection point between the entry-exit system of Magyar Gáz Tranzit and the entry-exit system of Eustream.

**Therefore, the amount of 0 for non-binding demand indications for firm technical capacities increase over existing level has been used as a basis for this demand assessment.**

## **B. Demand assessment**

### **i. Expected amount, direction and duration of demand for incremental capacity**

The received demand indications for firm technical capacities increase over existing level within the current incremental process for the interconnection point between Magyar Gáz Tranzit and the entry-exit system of Eustream are zero.



### **C. Conclusion for the (non)-initiation of an incremental capacity project/process**

According to the 2017 second quarter assessment result of the non-binding demand indications under **point B (technical capacities increase over the existing level at the interconnection point between Magyar Gáz Tranzit and Eustream)**, no demand levels for incremental capacity need to be developed.

No technical studies for incremental capacity projects will be conducted under the aforementioned regulation, although Eustream and Magyar Gáz Tranzit keep the right for monitoring of the demand and conduct studies for capacity increase at the SK-HU interconnection point as per their Ten-Year Network Development Plans.
